We are privileged to present the Zimhealth Annual General Report for 2019, a year in which our members had challenges and moments of joy as well. It is Zimhealth's aim to identify new projects in conjunction with other stakeholders and solicit funding for support during the 2020/21 operational year.

One of the most important aspects of our work in the reporting period was to raise awareness among Zimbabweans and their friends about the existence of Zimhealth and the need to support its cause for the benefit of the generality of Zimbabweans. To achieve this goal, our publicity and resource mobilization teams, through various programs, reached out to Zimbabwean communities within Switzerland and abroad in a membership drive and resource mobilisation. 01 INTRODUCTION

The Zimbabwe Network for Health (ZimHealth) is a non-profit organization registered in Geneva, Switzerland founded by Zimbabweans and friends of Zimbabwe in 2008. Membership is mainly across mainland Europe and the United Kingdom.

The objectives of ZimHealth are to

Inform, educate and communicate the status and needs of the Zimbabwe public health delivery system to all Zimbabweans in Switzerland and the rest of Europe.

Raise funds and other support from individuals in Switzerland and the rest of Europe and from private corporations and international, multilateral and bilateral agencies.



Distribute equitably funds and materials to health services in all provinces and districts of Zimbabwe, as far as resources allow.

The ZimHealth 2016-2020 Strategic Plan outlines the following intervention areas as key priorities for the organization during this five-year period;

- Advocacy, communication, and catalysing support for Zimbabwe public health system.
- Replacement of essential medical and other equipment in public health facilities.
- Renovation and rehabilitation and expansion of public health infrastructure.
- Support for infection prevention and control, as well as water and sanitation in health facilities.
- Support for Zimbabwe health workforce development with special focus on international exposure.

ZimHealth relies significantly on the beneficence of its dedicated core membership and partners old and new with a collective call for action and responsibility to achieve more by providing not only for family and friends but also including other fellow country women and men in Zimbabwe.

The activities of ZimHealth are coordinated by a fully voluntary Executive Committee which is elected yearly at an Annual General Meeting.

02 STATUS OF HEALTH AND HEALTH SERVICES IN ZIMBABWE

Hospitals and primary health care facilities owned by government, faith-based organisations and private organisations including insurance providers provide health services in Zimbabwe. The majority of the population is serviced by government, municipalities and faith-based care centres. According to the Zimbabwe National Health Strategy (2016-2020), every district in Zimbabwe has at least 2 doctors, every primary health care centre has at least 2 qualified nurses, 59% of administrative wards are serviced by an Environmental Health Technician and 60% of villages have access to a village health worker.

Zimbabwe has seen some improvements in health achieving a 23% reduction in the maternal mortality ratio from 570 to 458 per 100,000 live births between 2010 and 2017 (Maternal Mortality Estimation Inter-Agency Group, 2019). Mortality in children under 5 years had a 46% reduction from 86 to 46 deaths per 1,000 live births between 2010 and 2018 (UN Inter-agency Group for Child Mortality Estimation, 2019) while the number of new HIV infections and AIDS-related deaths declined by 38% and 60% respectively (UNAIDS AIDSInfo, 2019).

The progress is however reported to be uneven as the poor and marginalised children and their families remain worse off, necessitating more equitable health care spending by the government. According to UNICEF supported 2019 Zimbabwe Multiple Indicator Cluster Survey, under-five mortality rate for the poorest quintile was estimated at 91 per 1000 live births, compared to 51 per 1000 live births for the richest quintile. This upward trend in inflation acts as a barrier in accessing health care services. The current public spending is inadequate to address the current

health challenges facing the nation, including some preventable causes of mortality among children, which can be avoided with adequate funding of the sector. Furthermore, the country is prone to natural and man-made disasters including frequent disease outbreaks, acute public health emergencies and other healthrelated humanitarian disasters.

Whilst development partner support remains important for Zimbabwe, sustainability requires greater domestic resource mobilisation, to avoid reliance on declining donor support.

It is against this background that ZimHealth seeks to continue to support health facilities providing maternal health services to contribute to access among the disadvantaged population. The focus for ZimHealth has traditionally been maternal health services and infection control but in 2016, the new ZimHealth Strategy 2016-2020 expanded the focus to include advocacy for support for the public health system in Zimbabwe, water and sanitation and health workforce development. 03 KEY ACHIEVEMENTS AGAINST THE STRATEGIC PLAN

3.1 Strategic Area: Publicity Communication and Membership

In 2019, ZimHealth made progress in the strategic areas of advocacy and communications, as it reached out to the general public and spread ZimHealth's core message of health for all.

ANNUAL FUNDRAISING EVENT

The 2019 Annual Fundraising event was held in Versoix on the 14th of September. The event, as in previous years, was a music concert this time featuring the world famous Afro-fusion Zimbabwean band, Mokoomba. The event was held at the Versoix Community Hall and was a celebration of Zimbabwean arts and culture. The performance by Mokoomba was both an electrifying and moving experience. The band gave their all in almost three hour performance and brought a little bit of Zimbabwe into Switzerland that evening.

Sadly attendance to the performance was low with just a little over half of the tickets being sold. This contributed to ZimHealth making a loss of just over three thousand Swiss Francs. Several long standing ZimHealth members have generously come forward to help cover the shortfall generated by the fundraising event and we are sincerely grateful to them.

Because of this the Executive Committee, cognisant of the fact that though the event worked towards raising publicity for the organisation, recommended that the Publicity and Communication Committee scale down the magnitude of the annual fundraising event and instead host several smaller, less capital intensive events throughout the year rather than one very large capital intensive event which demanded a lot in terms of financial investment, the time and effort of members and strained the organisational capacity of our members to the limit. This resolution was adopted by the current Committee.

WEBSITE, SOCIAL MEDIA AND PUBLICITY

2020 MARCH CONTACT LIST **362** CONTACTS WITH OVER **70** REGISTERED AS MEMBERS

The contact list of ZimHealth as of March 2020 stands at 362 contacts of which over 70 are registered as members. This is a slight increase on the preceding year's 60 registered members. As in previous years, our main engagement was driven by Facebook and more recently Twitter.

ZimHealth continues to maintain regular communications with the Ministry of Health, city councils and Zimbabwe Association of Church Hospitals (ZACH) and other relevant stakeholders, to update on the status of public health services in the country, identify key needs for support and advocate for key public health interventions.

ADVOCACY

30 DIGITAL THERMOMETERS, **6** BP MACHINES AND **4** GLUCOMETERS TO BINGA CLINIC IN ZIMBABWE THROUGH ONLINE DONATIONS.

Thanks to the work of the Chairman, Mr Ngonizashe Hove, the Committee partnered with the Webster Humanitarian Association to launch an online appeal for donations that enabled the donation of 30 digital thermometers, 6 BP machines and 4 glucometers to Binga Clinic in Zimbabwe.

In response to Cyclone Idai, which hit Mozambique, Zimbabwe and Malawi in March of 2019 and caused an unprecedented humanitarian crisis and left more than 1300 dead and hundreds of thousands dead, ZimHealth launched an appeal to its members and supporters to help victims in Zimbabwe. The appeal brought in 783 USD and over 100kgs of clothes.

3.2 Strategic Area: Replacement of Essential Medical and other equipment in public Health Facilities

Through ZimHealth's collaboration with the City of Harare, Binga Hospital, Mberengwa Rural District council, five health facilities were supported in 2019. These facilities received medical equipment, renovation materials, furniture and appliances (Table 1), at a total cost of over USD50,000.

The health facilities were initially set up as mission hospitals run by religious institutions in the country. However, prevailing economic conditions have resulted in limited resources being available to support the facilities. As the facilities are mostly rural, the support provided will hopefully help to ensure that populations in remote areas are able to access decent health services.

3.3 Strategic Area: Renovation, rehabilitation and expansion of Public Health Infrastructure

In 2015-2017, ZimHealth supported the expansion of Mabvuku Clinic from a primary health centre that was providing basic health services, to a state-of-the-art polyclinic / district hospital with a maternity theatre and A&E services. The ZimHealth Executive Committee is in communication with the City of Harare and the Ministry of Health and Child Care regarding the official opening. The facilities are, however, fully functional although facing requisite staff.



04 MONITORING AND EVALUATION

Monitoring and evaluation of projects remained vital to Zimhealth's endeavor to remain accountable to both donors and the target population. 2018 saw the operationalization of our evaluations tools. This was a milestone in ensuring Zimhealth maintained unquestionable transparency, accountability and to build capacity to continuously and efficiently assess intended outcomes. This will be consciously pursued in 2019 and information resulting from these efforts will be shared with all stakeholders. This will not only enable Zimhealth to maintain the desired ethical practices but also serve to inform a healthy decision-making process.

Members made visits to conduct physical assessments of some prospective projects and those that had received support. Some projects that were visited and assessed in 2019 are Chinengundu Clinic, Chegutu, Mashonaland West Province, Harare Province), Matedzi Clinic in Mberengwa district, Midlands Province. Many projects, new and old, still need to be visited and efforts will be made, in earnest, to visit projects in order to evaluate the impact of the support provided.

Visits were made to new projects including the Cancer Association of Zimbabwe's Zororo Cancer Clinic located in Harare and a potential new project, Chinotimba Clinic at Victoria Falls.

05 RESOURCE MOBILIZATION AND FINANCE



DIRECT CONTRIBUTIONS FROM MEMBERS TOTALLED USD 6,807 AVERAGING USD 567 PER MONTH Although some requests for funding were submitted to potential supporters, no new funding requests were realized in 2019, although one fundraiser event was held and is reported on above. Direct contributions from members totalled USD 6,807, averaging USD 567 per month.

Income totalled USD 19,562, and total expenditure was USD 64,654. As of 31 December 2019, ZimHealth held a total balance of USD 15,656. The detailed financial report is presented as Annex 1.



06 Administration

Annual and Financial Reports from previous years were submitted to the Centre d'Accueil de la Genève Internationale (CAGI) for the purpose of maintaining our registration as a non-profit. The ZimHealth address was maintained in Meyrin and as of 2019, all members of ZimHealth were full time volunteers.

09 ANNEX 1 2019 FINANCIAL REPORT

Zimbabwe Network for Health (ZimHealth) Europe Treasurer's Annual Report: 2019

This report summarizes the financial activities of the Zimbabwe Network for Health (ZimHealth) Europe for the period 1 January 2019 – 31 December 2019.

1. Overview

Since its inception in 2008, ZimHealth has maintained two bank accounts, in Swiss Francs (CHF) and United States Dollars (USD), as well as a PayPal USD account. In 2017, ZimHealth established a partnership with the Daniel Low-Beer Foundation and Albert Nyathi on their 10 Conversations¹ initiative, which seeks to promote health through music and poetry. To facilitate tracking of funds linked to this partnership, ZimHealth has since opened a third USD account, through which incomes and expenditures related to the work on health promotion are administered. As of 31 December 2019, ZimHealth held a total balance of USD 15,656 (Table 1).

2. Income

Table 2 summarizes the sources of income in 2019. As no funding proposals were submitted in this period, the income was relatively low compared to other years.

The gross income generated from the Mokoomba Fundraiser Concert was CHF 8,579 (USD8,863), against fundraising expenses of CHF 11,782 (USD 12,172). To recover the losses incurred from this event, members donated CHF 1,400 (USD 1,446), and additional donations have been pledged for 2020. The summary of gross income and expenditures for the concert is attached as Annex 1.

Membership contributions averaged USD 577 per month, with a total of USD 6,930. This is an increase from 2018, where monthly contributions from members totalled USD 5,905 and averaged USD 492. The number of members contributing fees on a regular basis has not changed; approximately 10 members regularly pay their membership fees.

3. Expenditure

Expenditure in 2019 totalled USD 64,654 The bulk of funds (79%) were spent towards the purchase of equipment for four health facilities: Binga, Glen Norah, Mataga and Matedzi Clinics, as well as the refurbishment of Tariro Cancer Hospice in Harare.

Following donations of CHF 1,400 from members to recover the losses incurred from the concert, the balance was -CHF 1,803 as of 13 December 2019. Additional donations have been pledged for 2020.
